2. A proposal from the Department of Journalism, Communication and Theatre to change the name of the major and the B.A. Degree requirements was approved
3. Proposals from the Department of Journalism, Communication and Theatre to create new courses MMS 218, 219, 322 and 335 were approved
4. Proposals from the Department of Journalism, Communication and Theatre to create new courses MMJ(MMS) 217, MMS 223, 224, 250, 307, 308, 324, 350, 360 and 366 were approved, pending minor editorial changes.
5. A proposal from the Department of Journalism, Communication and Theatre to create a new experimental course MMS 220 was approved, pending minor editorial changes.
