- A detailed discussion of the findings was held. It was noted that there are common areas with what Lehman College is doing.
- Suggested policies and practices for Lehman College's assessment were briefly discussed (a summary based on the meeting and ongoing work at Lehman can be found in Attachment 2).
 The suggested policies and practices will be discussed at a future AAC meeting.
- Council members liked the idea of the Senate Committee's bringing assessment issues before the Senate (incorporating assessment into shared governance)
