- Associate Provost Robert Whittaker for his role. There is more work ahead but he stated that, in
- 41 this document, Lehman addressed the serious concerns of the campus.

- 47 hours are insufficient. The Student Legislative Assembly's 100 hours campaign seeks to increase
- 48 the library's hours of operation from 76 to 100 hours.
- 49 2. In response to Ms. Gomez's report, Chief Librarian Kenneth Schlesinger stated that the
- Library faculty had a productive meeting the day before with the student government. He added
- 51 that during this meeting, he requested recommendations from the Student Legislative Assembly
- 52 concerning their library usage needs. Discussion followed. There will be a follow up meeting to
- address these concerns.

- He then presented the Governance Committee's Pathways Resolution (see attachment I.)
- Discussion followed resulting in the following amendments to the resolution:
- In the 4<sup>th</sup> whereas clause, "may" replaced "will." The clause reads:

### LEHMAN COLLEGE SENATE

### PATHWAYS RESOLUTION NOVEMBER 2011

Whereas the CUNY Chancellery and the Board of Trustees have established Pathways committees that are proposing a new core curriculum for CUNY; and

Whereas these committees are composed of persons who were appointed by the university administration rather than elected by the faculty or duly constituted governance bodies of the colleges and the university; and

Whereas these committees are operating inside the inadequate, arbitrary and capricious constraint of a 30 credit Common Core and a 12 credit College Option for the baccalaureate curriculum; and

Whereas the prohibition of required prerequisites for core courses will result in a lowering of academic standards in General Education courses; and

Whereas the proposed curriculum is deficient in failing to include sufficient instruction in numerous areas, including but not limited to mathematics, foreign language, natural science, historical studies, philosophy, and political science; and

Whereas the CUNY Board Resolution mandates that CUNY colleges uncritically accept courses from colleges outside CUNY, including courses of questionable academic quality and unspecified learning outcomes;

Whereas Lehman and the other colleges were given only two weeks to respond to the draft Common Core proposal;

Be it Resolved that the Lehman College Senate, comprised of faculty, students, and administrators, condemns the Pathways process that is damaging to the academic reputation of Lehman College and the City University of New York and the careers of our graduates.

Be it further Resolved that the Lehman College Senate recommends that the Pathways program be scrapped and that colleges be assisted in establishing collaborations to enhance articulation and the academic quality of CUNY baccalaureate degrees.

### Attachment II

Lehman College makes the following recommendations to the Common Core Draft of November 1, 2011. The rationale behind these recommendations is presented in the endnotes indicated.

- I. Recommendation to add specific content to the learning objectives of the <u>Required Common Core</u> category C. Life and Physical Sciences, namely

  Identify and apply the fundamental concepts and research methods of one of the following disciplines: physical anthropology, astronomy, biology, chemistry, geology, geography and physics.
- II. Recommendation to revise the first learning outcome in the <u>Flexible Common Core</u> category **D Individual and Society** to read as follows:
  - Identify and apply the scientific method to explore social and behavioral phenomena such as the relationship between the individual and society, including, but not limited to the concepts and research methods of anthropology, computer science, philosophy, psychology, religion, and sociology.
- III. Recommendation to add a fifth area to the <u>Flexible Common Core</u>, such that this category includes five areas of 3-credit liberal arts courses, and such that a student must take at least one course from each of the <u>five</u> areas and no more than one course in any discipline.
- IV. Recommendation that this fifth area be:
  - E. Languages and Literatures. Students must take at least one foreign (non-English) language (non-duplicative of previous language acquisition) Or literature taught in anon-English language at the intermediate level or above, or demonstrate non English language competence at least at the intermediate level Or a student may take a course in English grammar, syntax, Or linguistics (for which there is no pre-requisite). Language and literature study must meet *three* of the following learning outcomes:
    - Identify and apply the fundamental concepts and research methods of a language other than English or of linguistics and of world cultures.
    - Analyze the concept of culture and global cultural diversity and describe any given event or process from a cultural viewpoint other than English-language cultures.
    - Analyze the structure or development of a non-U.S. society.
    - Identify and discuss the role that race, ethnicity, class, gender, or belief plays in linguistic or cultural systems.
    - Speak, read, and write a language and use the conceptual skills to appreciate and respond to cultures other than one's own.
  - V Recommendation to revise the title in the Flexible Common Core category A. World Cultures to read: World Cultures and Societies."
- VI Recommendation to revise the learning objectives in the **Flexible Common** Core category **A. World Cultures** to read as follows:

- Identify and apply the fundamental concepts and research methods of a discipline or
  interdisciplinary field exploring world cultures and societies, including, but not limited to,
  anthropology, economics, foreign languages (non-duplicative of previous language
  acquisition), history, sociology, philosophy, ethnic studies, geography, political science
  and world literature.
- Identify and discuss the role that race, ethnicity, class, gender or belief plays in world cultures and societies.
- Speak, read, and write a language and use the conceptual skills to appreciate and respond to cultures and societies other than one's own
- Analyze the historical development of one or more non US societies
- Analyze the significance of one or more major movements that have shaped the world's societies.
- Analyze the major themes of globalization from different cultural, social, economic, historical, or political perspectives.

# Senior College Model

University Budget Office November 11, 2011

## Instruction and Departmental Research

- Faculty: The Instructional Staff Model is used to fund faculty. Funding is based on FTE enrollment, student credit hours by discipline, and student faculty ratios by discipline to generate FTE teaching requirements. FTE faculty are funded at differential salaries by discipline. Undergraduate faculty positions are funded at 70% of the full-time salary and 30% of the part-time salary. Graduate faculty positions are funded at 80% of the full-time salary and 20% of the part-time salary.
- □ I&DR Support: Support funding is based on support ratios by discipline adjusted by a factor for the number of academic programs by campus.
- □ OTPS: Funded on a per student FTE basis.
- □ Research: Funding is provided at a level of 10% of college research awards.

### Library/Organized Activities

- Staffing: Current full-time filled levels are funded at the college average salary, with adjustments to ensure "points of service" coverage.
- □ Temporary Service: Funded at a percentage of PS Regular expenditures.
- □ OTPS: Funded on a per student FTE basis.
- □ Source: Recommendations of the University's Chief Librarian

# Student Services, General Administration, General Institutional Services

- Staffing: A base number of positions are assigned, determined by a bi-variate and linear regression analysis. Additional positions are allocated per a prescribed ratio of staff to students. Filled full-time positions are funded at the college average salary. Vacant positions are funded at the senior college average salary.
- □ Temporary Service: Funded at a percentage of PS Regular expenditures.
- □ OTPS: Funded on a per FTE basis.

## Maintenance and Operations

- Staffing: Based on gross outside square footage and acreage per campus. Position levels are allocated to four categories:
  - Administration: College filled position level @ college average salary.
  - Custodial Services: A base number of positions needed is determined using bi-variate and linear regression analysis. The number of additional groundsmen needed is determined by acreage with one additional position needed for every ten acres, with a number of positions added using a density adjuster.
  - Maintenance: Bivariate and linear regression analysis is used to determine a base number of positions needed with a number of positions added as determined by a horizontal adjuster and a density adjuster.
  - Utilities: Utilities positions are based on filled levels rather than model due to widely varying physical plant types and staffing needs.
- □ OTPS: Funded by square foot and increased annually to account for inflation.
- Source: Square footage and acreage data provided by the Office of Facilities Planning, Construction and Management.

## Security

- Staffing: Current filled levels are funded, with adjustments made as per recommendation of the Director of University Security.
- OTPS: Contract security is funded at actual levels. General OTPS needs are funded in the GIS allocation.
- □ Source: Office of University Security

### Attachment IV

### UFS Report to the Lehman College Senate, November 16, 2011

VC Schaffer presented the proposed **CUNY Bylaw changes** to the Board Committee on Faculty, Staff and Administration on October 31. They now go to the full Board at its November 28 meeting. According to the Chair of the UFS Legal Affairs Committee, much of the Graduate School Governance has been removed from die document and must be revised by the Graduate Council. The original draft of the Bylaw changes had been significantly revised after comment by the PSC and the UFS.

The proposed CUNY **International and Domestic Travel Guidelines** were passed by the BoT Committee on Academic Policy, Program and Research (CAPPE). They also go to the full Board at its November meeting.

CAPPR also passed the College of Staten Island Letter of Intent for a **Doctorate in Nursing Practice.** The Graduate Center's Doctoral Faculty Policy Committee filed a written objection based on a lack of approval from the Graduate Council. The DPPC has announced that they will-continue to object to die full proposal. The DFPC is not a UFS affiliate.

Both of the above items are subject to public comment at the Board Public Hearing on November 21.

The continuing Pathways process is engendering a new round of opposing resolutions by college student and faculty groups. I had reported on the resolution of the Chairs and Program Directors of the Hunter College School of Arts and Sciences. New actions include a petition drive by language students at Hunter College, a resolution by the Faculty Council of Brooklyn College and a resolution by Queens College academic senate, which stated that the Academic Senate of Queens College concludes that the Pathways to Degree Completion Initiative cannot be redeemed by minor changes to its individual components and rejects Pathways on pedagogical, intellectual, and legal grounds.

Acting under the Board's Pathways Resolution, GC President Kelly has announced disciplinary committees that will **impose the first three to six courses that lead into the largest transfer majors at CUNY.** The first majors to receive this attention are biology, business, criminal justice, English, nursing, psychology, and teacher education. Other majors follow. Lehman College faculty members serving on the committees are: Alice Akan, Nursing; Grace Bullaro, English; Mario Gonzalez-Corzo, Business Administration; and Vincent Prohaska, Psychology.

News reports indicate possible NYPD violations of the 1985 **Handschu settlement** and the 1992 NYPD-CUNY Memorandum of Understanding Regarding Police Response to Incidents & Events Occurring at CUNY. These reported violations relate to **surveillance of groups engaged in political activities** and have been the subject of faculty resolutions at the two CUNY colleges. Last night the UFS passed a resolution supporting continued implementation of the Handshu settlement guidelines.

The CUNY Academy has announced that applications are now available for **Stewart Travel Awards**. This award, for up to \$500, is designed for full-time faculty in the first three years of service to the College. Travel must take place from July 1, 2011 to June 30, 2012.
