Minutes of the Meeting March 12, 2014
Senate Undergraduate Committee on Curriculum

A quorum was not present. All votes taken were unanimous.

1. The committee approved the minutes of February 19, 2014.
2. The committee approved proposals from the Department of Music to change the Degree Requirements of Music, B.S., to create new courses MSP 2060 and 2070, to change the credits of MSP 201, MSP 202, 205 and to change the title and course description of MSP 203.
3. Proposals from the Department of Philosophy to create a new interdisciplinary minor in Reason and Exposition and create a new course, PHI 4010, were approved.
4. The committee approved proposals from the Interdisciplinary Program in Linguistics to withdraw the cross listings of SPA(LNG) 310, RUS(LNG) 310, POR(LNG) 310, JAL(LNG) 310, ITA(LNG) 310, IRI(LNG) 3100, GRK(LNG) 315, GER(LNG) 310, FRE(LNG) 310, SPA 308(LNG), ITA(LNG) 308 and FRE (LNG) 308.
5. Proposals from the Interdisciplinary Program in Linguistics to create new courses LNG 3100 and LNG 3080 were approved.
6. A proposal from the Department of Biology to create an experimental course, BIO 2680, was approved.
7. Proposals from the Department of English to change the hours of ENG 111 and ENG 121 were approved.

Proposals from the Department of Journalism, Communication and Theatre to change the name and the Degree Requirements of the 42 credit major in Multimedia Journalism, B.A., the name and Degree Requirements of the 36 credit major in Multimedia Studies, B.A. and to create a new 42-43 credit major in Media Communications Studies, B.A. were approved, subject to revisions.

360 and 404 and the alpha code title and prerequisites of MMJ 350 were approved, all pending minor editing and electronic review of the revisions by the Undergraduate Curriculum Committee.
