



## Early Childhood Education with Bilingual Extension

### Master of Science in Education

The 39-45 credit program leads to an M.S.Ed. degree in Early Childhood Education: Integration of Bilingual Extension (Birth-Grade 2), general education. The program leads to initial and professional certification in New York State and are designed for candidates who have received no previous certification in early childhood but may have certification in a related area, in keeping with the State's emphasis on dual certification. The program is designed to prepare reflective practitioners in urban early childhood settings. Our Early Childhood Graduate Program is nationally approved and accredited. We are committed to preparing competent, qualified, ethical, and reflective practitioners for service in diverse communities who believe in promoting care, justice, and equity in urban settings. Our students work in infant and child care settings, Head Start programs and in our public and private school systems, in Pre-kindergarten, Kindergarten, First and Second grades. The Bilingual Extension of the Initial or Professional Certificate enables one to teach effectively in bilingual settings. The requirements for the Initial or Professional Certificates must be fulfilled before a Bilingual Extension can be issued. In addition, the Bilingual Education Assessment (BEA) exam is required.

#### ADMISSIONS REQUIREMENTS

- Official transcripts from **all** post-secondary institutions attended (transcripts from a university outside of the United States must be evaluated by an approved agency)
- Have attained a bachelor's degree or its foreign equivalent from an accredited college or university
- Have attained a minimum undergraduate grade point average of 3.0
- Two letters of recommendation
- A 500-word essay in English outlining your journey to a master's degree, your intellectual and academic experiences and interests, accomplishments, and career objectives. Please include also a 500 - word essay in Spanish
- Interview with faculty member upon request

#### DEGREE REQUIREMENTS

To qualify for the M.S.Ed. in Early Childhood Education/Integration of Bilingual Extension (Birth – Grade 2), students must fulfill the following requirements:

- Submit passing scores on the EAS and CST exams, as well as a university-based early childhood certification exam.
- Complete 39-45 credits of prescribed course work
- Submit professional portfolio
- Apply for Initial or Professional Certification by completing all required courses as well as all the requirements for Bilingual Extension:
  - EDC 738 Literacy in Bilingual/Bicultural Early Childhood Settings, Birth to Grade 2.
  - EDC 739 Social Studies Concept Development in Bilingual/Bicultural Early Childhood Settings, Birth to Grade 2.
  - EDC 727 Teaching English as a Second Language (Pre-K to Grade 6).
  - AND**
  - EDC 709 Multilingualism in the Classroom, Birth to Grade Six
  - OR**
  - EBS 701 Issues in Bilingualism
- Pass Bilingual Education Assessment (B.E.A)
- The requirements for the Initial or Professional Certificates must be fulfilled before a Bilingual Extension can be issued
- Students must complete courses in three competency areas, including a supervised teaching experience. To progress from one competency area to the next, candidates must meet continuation requirements as listed below
